Cooperation Partners

The **University of Economics Ho Chi Minh City (UEH)** was established in 1976 and was selected by the Ministry of Education and Teaching as one of 23 national key universities in Vietnam. UEH is a multi-disciplinary university with approximately 45,000 enrolled students. With a multi-discipline structure in economics and business administration, UEH offers majors in development economics, business administration, finance & banking, accounting & auditing, management of information system, business law, and public management.



Established in 1966 **Can Tho University (CTU)** currently comprises 19 schools, colleges and institutes as well as centers. CTU, too, has been selected as one of 23 key universities in Vietnam. With around 58,000 enrolled students, CTU is the cultural, scientific and technical center as well as the largest and only public multi-disciplinary university in the Mekong Delta offering study programs in the fields of natural and social sciences, fishery, environmental studies, economics and pedagogics and is a leading agricultural research center in Vietnam.



Johannes Gutenberg University Mainz (JGU) can look back upon a long and successful history. Established in 1477, closed under Napoleon around 1800 and reopened in 1946 by the French occupying forces, JGU combines almost all academic disciplines in ten faculties, including the Mainz University Medical Center as well as a school of music and an academy of arts. With approximately 32,000 students from more than 130 nations, Mainz University ranks among the ten largest universities in Germany.



Founded in 1991 after the German reunification, the **University of Potsdam (UP)** is the largest university in Brandenburg with over 20,000 enrolled students and is located in proximity to numerous extramural institutes in the Berlin metropolitan area, which accommodates the highest density of research facilities in Germany. The University of Potsdam has six faculties: law, arts, human sciences, economics and social sciences, science as well as digital engineering (as the first privately financed faculty at a public university in Germany).



The ComO QM-Project

The project "Quality Management in Complex Organizations" which has been funded by the DAAD since 2015 as part of the line of "DIES-Partnerships: Dialog on Innovative Higher Education Strategies," deals with the development of quality management at universities with new challenges facing university governance.

ComO-QM project is a cooperation between higher education institutions in Vietnam and Germany involving Can Tho University and the University of Economics Ho Chi Minh City in Vietnam as well as Johannes Gutenberg-University Mainz and the University of Potsdam in Germany.

The heart of the project and, at the same time, its underlying method, is a procedure called Collegial Audit, a specific approach of collegiate exchange, in which the classically evaluative mode of an audit is offset in favor of a developmental perspective.

To this effect, actors from university management, faculty management, university lecturers and QA staff of the four partner universities came together for a systematic exchange on issues of higher education development.

The project aims at establishing an international network in the area of quality management as an opportunity to compare criteria and standards.
